



The liability of the Producer for the Product defects may not exceed the value of its purchase. The Producer shall not be liable for damages occurring as a result of a Product defect, such as the repair of damage, loss of profit or others.

Any damages resulting from the improper storage of the Product, the improper maintenance, assembly and use not compliant with the instruction manual and any other reasons not attributable to the Producer may be removed only at the Purchaser's cost. If the above-mentioned reasons cause permanent changes to the quality of the Product, the warranty becomes invalid.

The user is obliged to ensure access to the Product for the employees of factory service or any other company authorized by the Producer in order to examine the Product or remove the defect.

The distributor, on behalf of the Producer, does not bear any responsibility for the loss, damage or destruction of the Products resulting from reasons other than their inherent defects.

In particular the warranty does not cover:

- mechanical damages to the Product attributable to the user and defects resulting from them,
- malfunction of the Product due to assembly and use not compliant with the requirements of the instruction manuals accompanying the Products,
- malfunction of the Product due to its installation in buildings not constructed in accordance with the valid construction standards,
- defects resulting from the Purchaser's negligence or ignorance,
- operations indicated in the instruction manual which the user is obliged to perform on his/her own and at his/her cost,
- Product tampering by unauthorized persons, such as repairs, alterations, etc.,
- damages and defects occurring during transportation and the loading and unloading process and resulting from improper storage,
- malfunction of the Product due to damages resulting from improper storage,
- damages occurring as a result of acts of god beyond the Producer's control and the conditions of use (e.g. flood, fire, etc.),
- any changes of colour or its fading caused by such factors as sun/condensation/acid rain/salt as well as other occurrences causing corrosion,
- changes taking place in the Product or its components resulting from normal wear and tear, improper or limited use resulting from, for example, blockage caused by icing, snow, branches,
- any other damages, defects and faults which are not defects of the Product within the meaning of this warranty.

The distributor, on behalf of the Producer, as a warrantor reserves the right to assess and classify the damages.

If an unjustified warranty repair is unreasonably claimed, any costs connected with it shall be borne by the Person Reporting the Claim.

This warranty does not exclude, limit or suspend the Purchaser's rights due to non-compliance of the Product with the agreement.

The Purchaser states that the Product he/she received was complete, in working order and of good quality and confirms the receipt of the installation, use and maintenance manual and states that he/she hereby accepts the conditions of the warranty.
